MANAGER COMMENTS

The RIO Platinum account produced a 1.76% gain during August.

In time, we may well see platinum manufacturers decide to use platinum in petrol vehicles rather than palladium as the latter is now far more expensive in comparison. Another factor which could see periods of sharp upturn in the metals value is the fact that 75% of platinum is mined in South Africa. These mines have been affected by disputes over pay and working conditions, lack of power and water, and the instability of the Rand. For several years, South African platinum miners have been losing money. The decrease in the value of the Rand compared with other world currencies, coupled with strong demand for palladium and rhodium, have put them back into profit recently. These days, they are known as Platinum Group Metals (PGM) producers, rather than platinum miners because of the importance of palladium and rhodium in the mining process. An interesting trend is that there is building interest in platinum investment; such demand is becoming more widespread which is good news for the metal in the future.

INVESTMENT OBJECTIVE

As this global currency war has escalated there has been an increased risk of a currency debasement and the fact that platinum can offer protection from this event is very attractive in itself. Precious metals, including platinum, are often produced in emerging market countries, with demand coming principally from industrialised nations. The political and economic situation is, however, far less stable in many emerging market countries than in the developed world. They are generally much more susceptible to the risks of rapid political change and economic setbacks which affect precious metal prices and again provides scope for a strong upside.




