MANAGER COMMENTS



The RIO Regular Investment Account USD posted a positive month during February with a return of 0.33%, this was achieved despite the negative performance of both the Dow Jones and the NASDAQ. This month's gain has added to the account's impressive track record of gains versus losses and provides continued positive performance, this underlines the fact that it is one of the least volatile equity-based investments in the world. Recorded statistics show that this account has posted 80 gaining months and only 6 losing months since January 2016.

The return this month was in part due to trades in Boeing and Lockheed Martin. Boeing announced one of the largest orders in its history. Air India is gearing up its expansion plans and the order was for 220 firm jets: 190 Boeing 737 Max single-aisle planes and 20 of its 787 planes. It's the third-biggest sale of all time for the aircraft manufacturer. Lockheed Martin were awarded a \$1 billion U.S. Navy contract to install hypersonic missile strike capabilities onto the Navy's surface ships.

INVESTMENT OBJECTIVE

The RIO Regular Investment Account is a high-risk trading platform through which RIO invests in the currency, equities and commodity markets. The trading strategy favours a midterm investment of 4 - 5 years due to the expected short-term volatility.



CUMMULATIVE PERFORMANCE (Five Years)






